Notification under Section 708A (5)(e) of the Corporations Act 2001

On 23 June 2010, Saracen Mineral Holdings Limited (**Company**) announced the completion of a placement of approximately 92.1million new fully paid ordinary shares in two tranches. Shares totalling approximately 59.9million, comprising tranche 1 of the placement to raise A\$22.8 million before costs, were allotted on 30 June 2010.

The Company relied on section 708A(5) of the Corporations Act 2001 ("Act") when offering the placement shares. The Company gives this notice pursuant to Section 708A(5)(e) of the Act.
